Installation	The end of life of the packaging is taken into account at this phase. Transport of packaging to end of life treatment.
Use	 Under normal conditions of use, this type of product requires no servicing or maintenance. No consumables are necessary to use this type of product. Product category: PSR0003-ed1.1-EN-2015_10_16-Cable_Management_Solutions §3.2.3.1. Non-equipped service poles, service posts and multi-outlets extension. Use scenario: no energy consumption during 20 year working life. This modelling duration does not constitute a minimum durability requirement. Energy model: Electricity(US) - 2009
End of life	The default end of life scenario modelled maximizes the environmental impact using the PCR hypothesis for "Local transport": 621 miles (1000 km) by heavy truck and landfilling.


